RE: Cascade Gospel Chapel (Cascades Church) Anvil Retreat at Daybreak Point Bible Camp

We are so excited you want to come to Anvil Island for this retreat. We would ask that each person please sign below acknowledging and agreeing to the following:

- 1) This agreement is between Cascade Gospel Chapel Society (herein: the Society) and the individuals as acknowledged below (herein: camper). The signee (below) acts as a representative of the Camper and, in so far as the use of Cascade is concerned, assumes all liability pertaining to the actions of the working group.
- 2) The Camper releases the Society its employees, directors, volunteers, representatives and officers from all liability and waive against the Society recourse, loss or damage; including any consequential damage or loss, or claims as a result of their use of the property owned and operated by the Society (herein "the Facility").
- 3) The Camper acknowledges the inherent risks associated with a remote island facility. These risks include, but are not limited to: maintenance, waterfront activities, medical, transportation and general activity risks.
- 4) Any rules or regulations verbally communicated by a Society representative must be adhered to. Failure to do so may result in the Camper parties being escorted back to the Mainland.
- 5) In the absence of trained medical personnel at the Facility on Anvil Island the Society will take whatever emergency steps are required to aid the Camper in the event of a medical emergency. Notwithstanding, the Society cannot be held liable for outcomes as a result of medical emergencies.
- 6) The Camper understands that it is their responsibility to Act with caution while at the Facility and that the Society does not provide insurance coverage for it's guests.
- 7) The Camper acknowledges that the Society will not be held liable for damages to personal property nor physical injury. This includes theft and other damage that may occur as a result of activities participated on the Society's property.
- 8) The Camper acknowledges that we do not provide lifeguards and that they are aware that all boating activities and swimming must only be done under the supervision of a guardian for anyone under the age of 19 years. The Camper acknowledges that swimming will only be done during set times and in a set area. All kayakers will be required to wear lifejackets.

I, the undersigned have read, understand and agree to the terms of the use as set out above. I confirm that I am acting on behalf of myself and any underage children in my care and will inform and enforce the rules agreed to in this document. I understand that failure to abide by these regulations may result in the immediate removal of my party.
